- 1. Candidates should read carefully the requisite minimum essential qualifications, age and eligibility, experience criteria etc. laid down in the advertisement before applying for these posts. - 2. Application once submitted cannot be altered/resubmitted, under any circumstances. Further, no request with respect to making changes in any data/particular entered by the candidate in the Online Application will be entertained, once the application is submitted successfully. Therefore, please keep all data/details ready before you start filling up the Application Online.
- 3. The candidates are required to apply ONLINE and upload all the relevant documents relating to his/her educational qualifications, experience, etc. till 03.05.2021 upto 5.00 p.m. The application received after expiry of last date i.e. 03.05.2021 upto 5.00 p.m. will not be entertained and Institute will not be responsible for any delay. - 4. The candidate must be a citizen of India.
- 5. Good knowledge of computer applications (on word processor, spreadsheet, presentations, software etc. and OS like MS-Windows, LINUX etc.) will be a distinct plus.
- 6. Relaxation/concessions of age:
  - i) The maximum age limit for each post shall be the same as mentioned above against each post. The age shall be determined as on the last date of the submission of the application form, mentioned in the advertisement.
  - ii) Age is relaxable for 05 years for SC/ST candidates and 03 years for OBC candidates.
  - iii) Age relaxation to the departmental candidates will be in accordance with the instructions or orders of the Gol.

- 9. Separate application along with application fee should be submitted online for each post applied.
- 10. The number of vacancies indicated in the notification is tentative, IISER Mohali reserves the right to increase or decrease the number of advertised posts at the time of selection. Further, IISER Mohali also reserves the right NOT to fill any of the post advertised.
- 11. Candidates shall have to produce original documents along with one set of photocopies of educational qualifications, experience and reserved category certificate, if applicable, and application form submitted online, etc. at the time of interview (for posts at Sr. No.1 to 4) and for post at Sr. No.5 at the time of written test/skill test. In the absence of the same, candidature will not be considered for written test/ trade test/ presentation/ interview and no TA will be paid.
- 12. No correspondence whatsoever will be entertained from candidates regarding eligibility/conduct/result of written test/interview etc. and reasons for not being called for written test/ interview etc.
- 13. The Institute shall conduct written test/skill test for the posts at Sr. No.4 & 5. In view of number of applications,

the Institute may also conduct the Written test and Trade/Skill Test for posts at Sr. No.1 to 3 and only those candidates who qualify the said test(s) may be called for interview.

- 14. The prescribed essential qualification/experience indicated are bare minimum and mere possession of same will not entitle the candidate to be called for test/interview. Where number of applications received in response to an advertisement is large, it may not be convenient or possible for IISER Mohali to conduct test and/or interview of all the candidates. IISER Mohali may restrict the number of candidates to be called for written test/trade/skill test/ interview to be a reasonable limit, on the basis of qualification and experience higher than that of the minimum prescribed in the advertisement.
